Briefly throughout the property comprises of a LIVING ROOM with a fireplace, a MODERN FITTED KITCHEN with a good range of cabinets, CELLARS providing a useful storage area, a large FIRST FLOOR DOUBLE BEDROOM, a BATHROOM / WC with a corner bath, and a further SECOND FLOOR DOUBLE BEDROOM.

Access via a part glazed entrance door, double glazed window, central heating radiator, television point, fireplace with an inset pebble effect gas fire, ceiling coving, carpet, light neutral wall decoration, stairs to the first floor

Inner Hallway / Vestibule:

Stairs rising to the first floor, access to the kitchen.

Fitted Kitchen:

A modern range wall, drawer & base units, work surfaces, stainless steel sink and drainer with mixer tap, gas oven with four ring gas hob and chimney style extractor hood over, plumbing for an automatic washing machine, central heating radiator, external door giving access to the rear garden, access to the cellar.

Dry keeping cellar with power.

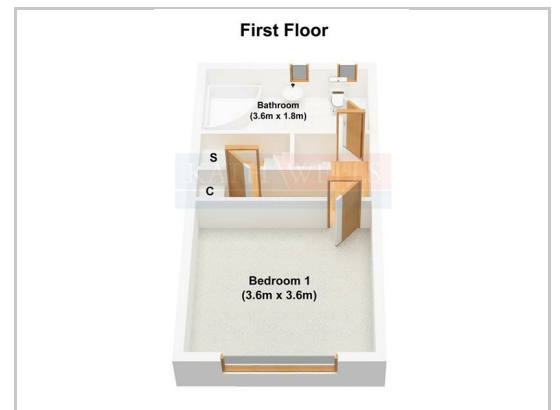
